Rental property update – bathroom remodeled, some repairs, no current major issues

New business:

Rick Rollman presented the findings of the subcommittee on how to purchase the property. Came up with two options:

- 1. Put 25% down, finance the balance
- 2. No money down, utilize the equity of 17 Main St. property and keep the cash reserves

Conference must approve the process of purchasing. In order to vote at the Church Conference, you must be present and a member to vote.

Finance Committee is working to change over the CD into an account where it is easier to withdraw from.

Eric Wentling recommended that when we present it to the congregation, we remind people that they can direct their money to a definitive cause (pay to the property)

Many thanks to the subcommittee that researched options and presented them to Council.

Motion to purchase the property at 74 McGillstown Road, Annville, PA 17003 from Ken and Kim Moyer at the price of \$195,000. The church would pay \$70K as a down payment (20K from building, 50K from CD) and closing costs from the CD to secure a 125K mortgage. The church conference (congregational vote) must pass with a minimum of 2/3 approval from members present: Staci Murray
